

NHRC SPONSORED ONE DAY TRAINING PROGRAMME
ON "HUMAN RIGHTS"

On 19.01.2019 our KLE Society's Arts and Commerce College Organized IQAC initiative One day training program on "HUMAN RIGHTS" by Department of Political Science in association with NHRC. Addressing at the inauguration of the program a well-known lawyers of Mr. G. C. Reshshi, said that conversion is the rule of the world that endangering the survival of human beings. He called for the role and responsibility of the youth in the protection of the environment and rights.

The chairman of the Local governing body Smt Rajani Patil expressed that in her presidential remarks that upliftment of human rights for the betterment of human rights and for the benefit of the students.

The program started with the prayer of Kumari.Niveveda, Prof. Sandhya Kulkarni introduced the dignitaries. Program Coordinator Prof, V C Chinnur Proposed Vote of Thanks, Prof. Shweta.Rachayyanara and Smt Nagashree Poojari hosted the event.

At the first conclave, Mr. G C Reshmi, a well-known lawyer, presented the concept of "Human Rights Introduction" { **Introduction to Human Rights** } the concept of universal rights around the world, in the form of the Constitution of the Indian Constitution. He also said that he preaches unity in different ways. Ramayana clarified with the illustrations of Basavanna, the ruler of the Ashoka period of the Mahabharata poetry. This event was hosted by Dr. A.V.Devangamath.

Mr. Santoshakumara Patil, a professor at S A Manvi Law School, who participated in the second conference as resource persons (**Human Rights Institutions in India**), said that "human rights institutions in India are meant to be human rights organizations only when they are meant to be human beings." Those who do not present a price to the human being are the seven important rights of equality, the right to freedom, the right to protest. Prof. I B Patil hosted the conclave.

Giving extensive information on educational rights and the right to constitutional remedies. Gadag and Belgaum District Child Protection Officer Mrs Bharathi Shetter, who was involved as a resource person at the 3rd conference on "Women and Children's Rights" said that the events of child marriage, sexual harassment and the abuse of women who are victims of the social fabric of the society need to be protected by such brutal incidents and there is a need to provide a healthy environment for their future. This event was hosed by Smt Hema Naik.

Mr. Basavaprabhu Hoskeri, a renowned lawyer from Dharwad, at the fourth concert, gave a detailed account of the rights of refugees, refugees and immigrants. At the closing ceremony, Kumari Padma Bellary and Kumara Bhagavantaraya expressed their views on the program. The closing remarks were delivered by Prof. M.B.Kolavi on how to use human rights. Smt. Sandhya Kulkarni proposed Vote of Thanks. Presentation by Nagashree Pujara and Shweta Rachaiah concluded with the presence of Prof. V C Chinura, staff and students.
