Procedure for Release of the Financial Support:

- ⇒ As an important post-accreditation quality sustenance activity, NAAC has requested the institutions to establish Internal Quality Assurance Cell (IQAC) in their institution. Hence organization of the seminar/workshop is mandated to be the activity of IQAC of the Institution.
- ⇒ The programme details of seminar/conference have to be sent to NAAC at least one month prior to the scheduled dates.
- ⇒ The sanctioned amounts should be spent exclusively on the programme for which the assistance is approved by NAAC.
- ⇒ The release of grants will be on completion of the event and submission of the bills/vouchers/Statement of expenditure and Utilisation Certificate within a month to NAAC. In case of any delay in submission of the claims the reimbursement will not be made and NAAC will not be liable for the expenditure incurred.
- ⇒ For better coordination organisers should be in communication with the respective Regional Coordinator at NAAC.

3. Theme of the Conference/Seminar/Workshop (Attach brief summary)

DESAGATI PRINCIPALITIES OF BOMBAY KARNATAKA (FROM 1565 TO 1947)

From 15th Cent. AD to pre independence era there existed more than 120 Desagati families of Belagavi, Vijayapur, Bagalkot, Kalaburgi, Dharwad, Gadag districts of North Karnataka and Pune, Satara, Kolhapur, Sangli Solapur Districts of Maharashtra. These families were predominantly followers of Shaiva, Vaishnava, Jaina, Muslim, Maratha and Kshatriya faiths.

The Vijayanagara Empire that ruled for more than two centuries had a number of vassal states within its fold. With its decline after the Battle of Talikota in 1565, many of its feudatories like Paleyagaras, Nayaka, Wadeyars etc. on one side and Adil Shahis of Bijapur on the other side started ruling over vast territories in Karnataka. They continued the administrative system of their over lords. Paraganas included 10 to 200 villages. Desai worked as mediator of society, protector of citizens, tax collector, judge and head of the army. For the purpose of easy administration Paraganas were divided into 'Samat' (80-100 villages), 'Taraf' (10-40 villages), Kasaba (20 villages), and 'Dap' which included 10-20 houses. We can see some other administrative divisions like Venthe, Venhaka, Valit, Chavadi, Magani, Seeme, Sarakar, Suba, Taluka, Peth, Hissar, Karyatu etc.

Deshkulkarni, Deshpande, Patil, Kulkarni, Jagirdar, Saradars were appointed to look after these Paraganas. The word Desagati is derived from two words, 'Des' and 'Gati'. The word 'Des' means specific area or place, 'Gati' means 'to have'. Thus the word 'Desagati' means having administrative responsibility of specific area or place. It seems that the word 'Desagati' was used in the records only. This word was not used by the common people. The people used to respect him as 'Dhani'. The office/post of Nadagouda which existed before 16th Cent. AD was later became popular as Desai (Deshamukh). Desai was head of the Desagati family. Because of his loyalty, powerfulness and service to his king he was given Jagir (Inam) by kings, which included vast territory. In turn Desais sent men to reinforce the army whenever the king needed his help and support. These Jagirs were called Desagatis, Paraganas, Hobali, Samsthanas etc. During this period many local principalities called as Desagati families rose to prominence.

After the downfall of Adil Shahis, the Peshwas, Hyder Ali, Tipu and even the British exercised effective control over these Desagati families. Some of the principalities like Patawardhans of Jamakhandi, Ghorpade of Mudhol, Nawabs of Savanur, and Desais of Ramdurg, Kittur, Mundaragi, Kurundwad, Belawadi, Wantamuri, Bailhongal etc. looked after the local administration and made significant contributions to several fields.

These Desagati families not only protected self esteem of their subjects, but also upheld religion, morality along with working as a bridge between king and citizens. Their post was hereditary. These families have given importance to the welfare of the people, public works, and construction of forts tanks temples etc. These principalities have rendered valuable contribution to the cultural development of their religion and also for the preservation and promotion of religious faith by organizing Fairs and Festivals (Utsavas). They lived like kings. They got titles from kings and land grants (Jahgirs) for their service. Some of the principalities, even though were under the overlords like Peshwas, they didn't give up their religious faith and even solved, many a time, problems with the help of Mutts; for instance, the Desais of Lakshmeshwar owed allegiance to both the Peshwas and Tippu and availed their assistance in local administration. During British rule, out of total collected revenue Deshpande used keep 1% and Desai used to keep 2% revenue from each village. Desai used to sign first on the records, later Deshpande signed adjacent to his signature. Musicians used to get prize first from Desai and later from Deshpande. The collection of tax was main responsibility of Desai, and Deshpande used to keep records related to the collected taxes. Even during the British rule, they expressed their allegiance to the company and the crown. It was only when the British assumed the district wise administrative responsibilities, these families started losing their importance.

Desais, Desamukhs, Deshpandes, Jahagirdars, Zamindars, Nayakas and Samsthanikas have built 'Vaades' (palatial structures) for their residence as well as for administrative work. They had faith in the saying "Rise like the sun and progress continuously (Suryanante udayisali, uttarottaravagi beleyali). Therefore almost all Vaadas were built East or North facing, symbolising progress and rise. These Vaadas have Treasury, Durbar hall, resthouse, bedrooms, pooja house, kitchen, and stables (rooms) to tie horses and elephants. The doors, pillars and roof pillars have beautiful carvings of local designs (Hagga murigi, nagamurigi, surigimurigi.) animals, dolls, birds, creepers, leaves etc. The oil extracted from Flax seeds and pine nuts was applied to bring shining on them.

However, there is no sufficient information on many of the principalities. There is an urgent need to call out the information on such principalities with the help of available foot prints as well as through Kaifiyats, books of Helavas, Lavanis and oral history sources from the people. That is why we would like to organize one day National level seminar on the topic 'Desagati Principalities of Bombay Karnataka'



The National Commission for Women was set up as statutory body in January 1992 under the National Commission for Women Act, 1990 with a mandate to safeguard the constitutional rights of women. In keeping with its mandate, the Commission has, from time to time taken various initiatives for gender awareness in the society against various social evils affecting rights of women. It has been experienced that gender-based discriminations exist throughout society, from organizational planning to the everyday interactions at the workplace and public space.

The Latin phrase: "*ignorantia juris non excusat*" which is applied universally provides that ignorance of law is no excuse. This principle is applied to laymen as well. Knowledge of laws/ remedies of one's country enable a person to stand for herself/ himself and fight against injustice in the society.

The reality of our existing legal and justice system is, that a large section of the population is handicapped by poverty, illiteracy and ignorance of law coupled with the complexity and obscurity of laws made and declared by the legislation. Due to this reason large section of people suffer from injustice both from the state organs as well as from individuals or group of individuals. They become victims of violation of their rights without any legal remedy. Despite declaration in the Preamble of the Constitution, of securing justice- *Economic Social and Political*, justice is beyond the reach of the large segment of the society. There is an urgent need to spread legal awareness amongst the people particularly the women of our country need to be imparted with knowledge of legislations made by the Parliament for their welfare and security.

Recognizing the need to impart legal awareness to women and girls, regarding their rights, the National Commission for Women has initiated a Countrywide Legal Awareness Programme. The Module is developed on the belief that education is a process through which society creates the kind of individuals we wish to see in the world. It is therefore proposed to go by 'Each one Teach One'. It's imperative that Legal Awareness Programme is introduced, for the male and female students of Colleges/ Universities, as it would lay strong emphasis on inculcating values of equality, inclusivity and diversity, all of which are essential for building a healthy society. Moreover, knowledge of Major laws of a country is not only crucial for balanced development of young minds; it will also help students' in formation of correct values, self-discipline and national spirit.

BASIC OBJECTIVES OF THE LEGAL AWARENESS PROGRAMME

- i. Impart practical knowledge about the basic legal rights and remedies provided under various women related laws, thereby making them fit to face the challenges in real life situations.
- ii. To sensitize men about rights of women.
- iii. To create awareness about the various machineries/organs of the Justice delivery system available for redressal of their problems/grievances.
- iv. The procedure of approaching and utilizing various channels available for the

- redressal of grievances i.e. the Police, the Executive and the Judiciary.
- v. The role of Courts in achieving gender equality, most importantly the concept of Public Interest Litigation.
 - vi. The role of District Legal Service Authority, Free Legal Aid and Lok Adalats.

Legal Awareness Programme aims to empower the youth of our country with the knowledge of their legal rights and duties, ultimately to be able to share power equally, gain full access to the means of development and to inspire a whole generation of women to work together towards achieving gender equality and justice. In order to achieve the aforesaid objective the National Commission for Women (NCW) has decided to lay down certain guidelines through this standardized module to be followed while organizing Legal Awareness Programme.

The guidelines formulated by NCW are meant for use by the implementing agencies, as guiding factor for conducting Legal Awareness Programme.

OBJECTIVES OF THIS GUIDELINES

- i. The purpose of the module is basically to describe the syllabus / laws with regard to which the legal awareness programme is required to be organized.
- ii. However the LAP Organizing University/ College can further elaborate upon the subject matter according to the need and requirements of the target group.
- iii. In this criterion, the category of the target groups and the concerned issues/problems will be the basis of generating Legal Awareness Programmes.

ELIGIBILITY CRITERIA FOR SELECTION OF ORGANISATION

- i. Applications for conducting legal awareness programme will be invited online by the NCW. The portal will be open for a specific time period for the Universities/ Colleges to apply. The announcement will be through a public notification on the website of NCW viz ncw.nic.in.


