### Report of the Lecture

The topic for the special lecture was "How can Swami Vivekananda help us in theorizing Indian traditions?". Dr. Shivakumar P. V., Assistant Professor, Government First Grade College, Byndoor, Udupi has delivered the special lecture. Sri Jagannathananda Swamiji of Sri Ramakrishna Ashrama, Gadag was the chief guest for the lecture programme.

Dr. Shivakumar P. who came as a special lecturer. He said that Swami Vivekananda was the one who preached the richness of Indian heritage by making people aware of their importance at a time when he was ridiculing the beliefs, rituals, festivals and traditions of Indians. At the age of just 19, Swami Vivekananda was a very logical, sharp and bright young man. He had the enthusiasm to question everything and also was expecting the logical answers for everything. This zeal and questioning spirit made him a disciple of Ramakrishna Paramahansa. Swami Vivekananda had many questions about his quest for the existence of God from a young age and when he was looking for answers to them, Ramakrishna Paramahansa had helped him to get darshan of God. Then he understood that through the Indian Traditions everyone can get the opportunity to join the god. He travelled all over the India and tried to make the traditions understandable. These traditions are playing an important role in a context like India where many cultures live together. Vivekananda said that he does not think the other sects as enemies but as various ways of finding

God Ramakrishna's association with him will help him overcome the criticism about the Hindu traditions. Similarly, he came up with a scathing critique of social reformers and Western missionaries who mistook Indian traditions and tried to destroy them, and devised alternative ways for understanding Indian cultures.

Swami Vivekananda participated in the Sarva Dharma Sammelan held in Chicago, USA and explained the essence of Indian heritage. Vivekananda's thoughts on Vedanta and spirituality are still helping us for understanding Indian traditions and practices. Each of the practices is spirituality the means of attaining salvation and bliss, and our philosophers provide guidance to correct certain traditions by criticizing practices that hinder the practice of spiritual practices but not trying to destroy them. Vivekananda opposed the Indian social reformers as they tried to destroy Indian traditions or culture in the name of reform. In this way Swami Vivekananda said that Vivekananda could help to understand Indian Traditions.

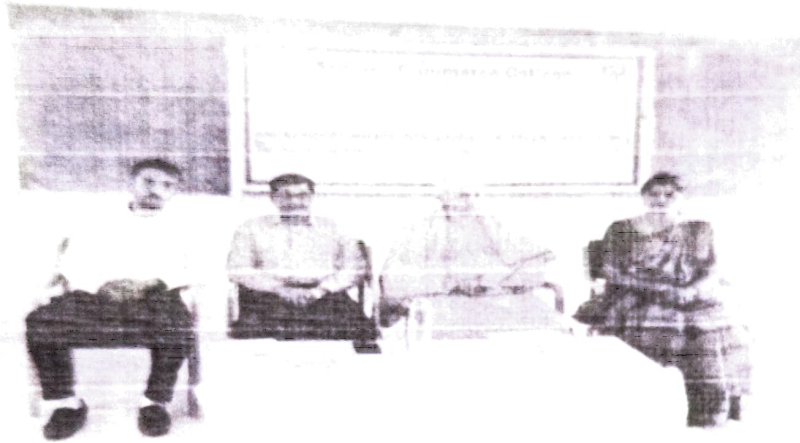
